After careful examination of the information contained in the references read above and in pursuance of the recommendations of the inspecting officer in the letter 6<sup>th</sup> read above, the District Educational Officer, Chittoor is pleased to accord Renewal of Recognition of classes I to V (E.M.) (without aid) during the academic year **2021-22 to 2025-2026** in respect of **Rainbow's English Medium School, Kanipakam Road, Pantrampalle Post, Chittoor, Chittoor District** subject to following conditions.

- 1) That the society shall abide by the instructions / rules and regulations made by the Government from time to time.
- 2) That the Educational Institution shall serve the needs of the locality more particularly
- 3) That the Institution shall adopt the curriculum prescribed from time to time by the Government.
- 4) The School timings, vacations and mid-term holidays shall be as prescribed by the Govt. from time to time.
- 5) That the qualified staff within the age limits prescribed by the Government for Govt. Employees shall be appointed as per the staff pattern.
- 6) That the results of the institution shall be satisfactory every year.
- 7) That the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
- 8) That the list of Governing body shall be furnished to the District Educational Officer every year.
- 9) That the pay structure /fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) That all the conditions prescribed in the G.O.s and other orders which are not specified in these orders shall be complied with.
- 11) That the school shall not be closed without giving notice both to the parents/ District Educational Officer and competent authority at least 6 months before.
- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall be submit proposals for renewal of renewal of recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 14) Only single section in each class is recognized.
- 15) The Management should follow the rules and regulations prescribed in Circular Memo.No.21748/D1/1997, dated:16.02.1998 and other orders of transport authorities regarding maintenance of school vehicles/ maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport authorities as prescribed by the Govt. from time to time.



- 16) The Management should have adequate personal guide, the movement of the children to ensure the road safety and transportation.
- 17) The Management should adhere the instructions issued by the District Educational Officer, Chittoor from time to time.
- 18) The Management should renew the lease documents of school building and playground well before the completion of the lease period.
- 19) The occupancy NOC issued by the DFO is valid for a period of one year from the date of issue and he should renew the NOC occupancy without fail.
- 20) The Management should submit the proposals for additional section permission to this office within one month without fail.




